Denton County has not adopted a mask mandate


Denton County provided a press release recently that explained that - The City of Denton, not Denton County, passed an unenforceable ordinance on Thursday, Aug. 12, 2021, requiring the development and implementation of a Health and Safety Policy to include requiring mask wearing in City of Denton buildings, commercial enterprises within the city limits, and all pre-k through 12th grade public schools and child care centers regardless of vaccination status.

The City of Denton's actions are not in compliance with the Governor's Order. To be clear, Denton County has never adopted a mask mandate.

The Governor's Order GA-38 on July 29, 2021 states: "No governmental entity, including a county, city, school district, and public health authority, and no governmental official may require any person to wear a face covering or to mandate that another person wear a face covering."

Denton County has always stressed the importance of vaccinations and continues to do so. Our Denton County Public Health has provided more than 404,000 COVID-19 vaccines, continues to provide free vaccines in weekly clinics, and continues to recommend all individuals follow CDC guidelines.

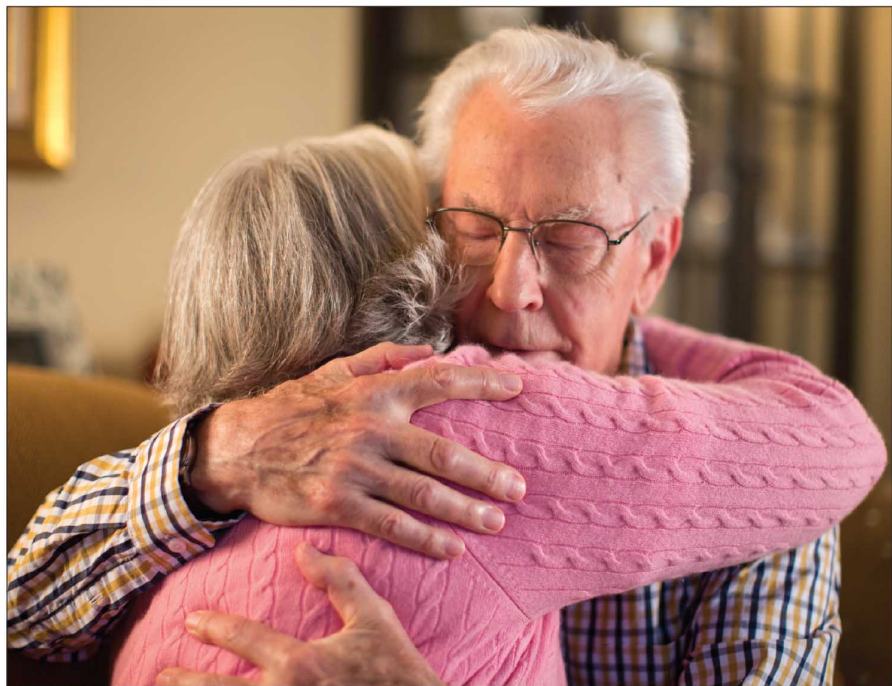

529 plans: Not just for college

If you've heard of 529 plans, you might think they can only be used to help pay for college. And you wouldn't be alone: Less than one-third of adults properly identified that a 529 plan can be used for more than just higher education, according to a survey by Morning Consult and Edward Jones. But what are these other expenses?

Before we get to them, let's review the main benefits of 529 plans. Contribution limits are high and earnings can grow tax-free if withdrawals are used for qualified education expenses such as tuition and room and board. (Withdrawals for nonqualified distributions are subject to taxes and a 10% penalty on the earnings portion.) Plus, as the account owner, you maintain control of the plan, so you can switch beneficiaries to another qualified family member, if necessary.

Now, let's consider the other uses of 529 plans,

which have been made possible by various pieces of legislation over the past few years:

Student loan repayments – The average amount of student loan debt per borrower is well over \$32,000, according to the Federal Reserve. So, many people welcomed the news that 529 plans could be used to repay student loans. There's an aggregate lifetime limit of \$10,000 in qualified student loan repayments per 529 plan beneficiary, plus \$10,000 for each of the beneficiary's siblings. Being able to use 529 plans to repay student loans gives you some flexibility if your family members have excess balances in their accounts.

K-12 expenses – A 529 plan can now be used to pay up to \$10,000 per year in tuition expenses at private, public and religious elementary and secondary schools. This amount is per student, not per account. However, not all states allow 529 plans to be used for K-12 expenses – or to be technical, some states consider K-12 tuition to be a nonqualified 529 plan expense, which means the earnings portion of a 529 plan is subject to state income taxes and possibly a “recapture” of other state income tax breaks connected with 529

plan withdrawals. So, make sure you understand your state's rules on K-12 expenses before taking money out of your 529 plan.

Apprenticeships – Not every child wants or needs to attend a college or university. And now, 529 funds can be used to pay for apprenticeship programs registered with the U.S. Department of Labor. These types of programs, which combine on-the-job training with classroom instruction, are offered at community colleges and trade schools. Once students complete their apprenticeships, they often go on to well-paying careers in a variety of fields. And since these types of programs are typically far less expensive than a four-year college degree, a 529 plan can have a particularly long reach.

The tax treatment of 529 plans for all these expenses can vary from state to state, so, if you move to another state after you've established your plan, you'll want to know the rules. Even if you don't move, it's still a good idea to consult with your tax advisor about how 529 plan withdrawals will be treated.

Nonetheless, a 529 plan could be valuable to you in many ways. Consider how you might want to put it to work for you and your family.

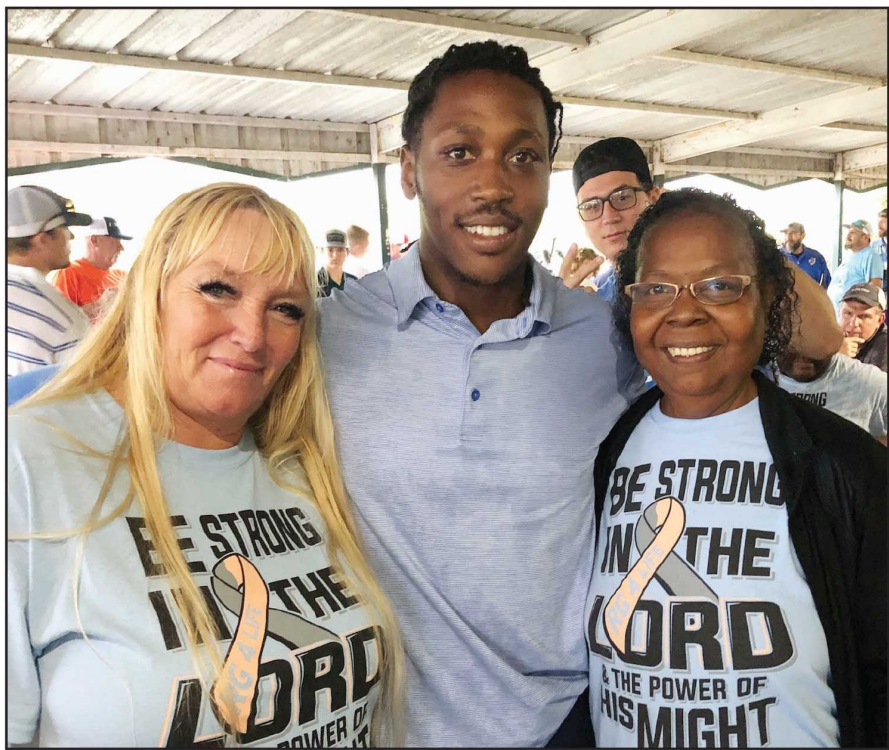

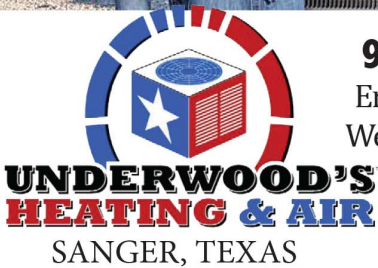

Sanger ISD has announced its policy that this school year, healthy meals will be offered every school day to all students at no cost. Typically, a student's household must meet income eligibility requirements to qualify for free or reduced-price meals. HEALTH & SAFETY PLAN

Sanger ISD Staff, Students and Families,

As you know, we are gearing up for an amazing school year in 2021-2022 with full in-person instruction only. Sanger ISD officials will monitor overall school health and safety and adjust plans as needed. Guidance from local and state officials, including the Texas Education Agency, will be followed and communicated as needed. When school starts on Thursday, August 19, the practices below will be in place regarding COVID-19 and variants. These practices are subject to change.

Masks & Hygiene Practices

As previously announced, masks and face coverings are optional for all students and staff. Staff are encouraged to ensure that any student wishing to wear a mask feels supported in their decision to do so. We will continue to promote the great hand washing and hygiene practices among all individuals on campus.

COVID-19 Reporting

Staff and students are asked to report any positive COVID-19 test result for themselves or for a household family member to your assigned campus nurse. **See chart at the bottom of this document.**

Quarantine Requirements

Lab confirmed individuals are required to quarantine for 10 days at the onset of symptoms or the date of test administration if asymptomatic. Quarantine for 10 days will also be required for individuals with a COVID-19 positive household family member. Vaccination status and COVID-19 history can overrule this quarantine period. Please reach out to the campus nurse for details.

Contact Tracing

Sanger ISD will not conduct contact tracing for COVID positive cases on campus. School nurses will resume normal protocols for contacting parents of ill children. As always, please remember that students must be free of fever, vomiting and/or diarrhea for 24 hours (without Medication) before returning to school to prevent spread of illnesses. Should the campus request you to pick up a sick child, please do so as promptly as possible.

Cleaning

Custodial teams will continue to provide extra cleaning measures in areas as needed to combat germs and spreading of illnesses of any kind. Hand sanitizer stations and surface wipes will continue to be available.

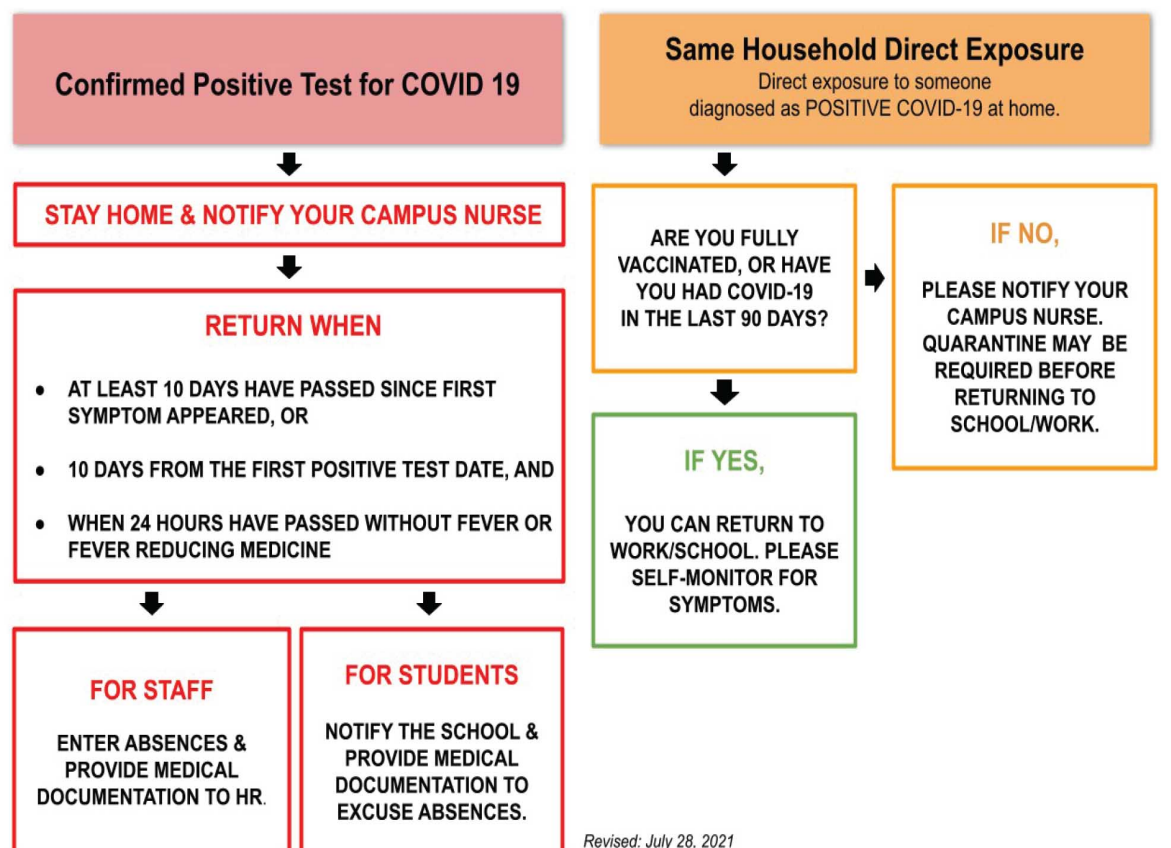
Remote Conferencing Learning for Positive COVID Positive and or Quarantined Students

If a student has to quarantine for being COVID positive or Same Household Direct Exposure, the student may be counted present and/or gain attendance credit by accessing our remote learning conferencing. During the required 10-day quarantine, the district's COVID Remote Conferencing Support Instructor will provide the student instructional support.

According to the Texas Education Agency (TEA), students participating through remote conferencing will generate attendance according to the two-through-four-hour rule and based on whether the student is virtually "present" at the official attendance-taking time. Instruction must be provided synchronously, which means two-way, real-time/live virtual instruction between teachers and students. The instruction cannot be concurrent, which means remote students must not be taught by a teacher who is also teaching in-person students at the same time. 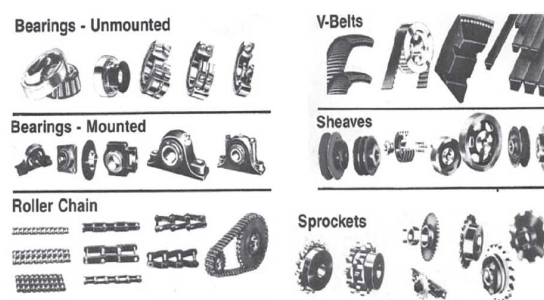
