

Sanger's Challenge Program recognized by Houston Chronicle

This school takes in kids facing the biggest mental health challenges

There are only eight kids in this class at Linda Tutt Learning Center in Sanger, but the chaos erupting throughout the room and spilling into the hallway would set any teacher on edge.



NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR TPDES PERMIT FOR MUNICIPAL WASTEWATER

MAJOR AMENDMENT

PERMIT NO. WQ0014372001

APPLICATION AND PRELIMINARY DECISION. City of Sanger, P.O. Box 1729, Sanger, Texas 76266, has applied to the Texas Commission on Environmental Quality (TCEQ) for a major amendment to Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0014372001 to authorize adding an outfall (outfall 002), the addition of two phases, and an increase in the discharge of treated wastewater to a volume not to exceed a combined annual average flow of 1,860,000 gallons per day. The current permit authorizes the discharge of treated domestic wastewater at an annual average flow not to exceed 980,000 gallons per day. TCEQ received this application on April 5, 2021.

The facility is located at 300 Jones Street, Sanger, in Denton County, Texas 76266. The treated effluent is discharged via Outfall 001 (pre dam breach) to Ranger Branch, thence to Paddock Lake, thence to Ranger Branch, thence to Clear Creek, thence to Lewisville Lake in Segment No. 0823 of the Trinity River Basin; or via Outfall 001 (post dam breach) to Ranger Branch, thence to Clear Creek, thence to Lewisville Lake in Segment No. 0823 of the Trinity River Basin; or via Outfall 002 to Ranger Branch, thence to Clear Creek, thence to Lewisville Lake in Segment No. 0823 of the Trinity River Basin. The unclassified receiving water uses are minimal aquatic life use for Ranger Branch (upstream of Paddock Lake) and Ranger Branch (downstream of remnant dam), high aquatic life use for Paddock Lake (before dam breach), Ranger Branch (downstream of Paddock Lake before dam breach) and Clear Creek, and limited aquatic life use for Old Paddock Lake section of Ranger Branch (after dam breach). The designated uses for Segment No. 0823 are primary contact recreation, public water supply, and high aquatic life use. In accordance with 30 Texas Administrative Code § 307.5 and the TCEQ implementation procedures (June 2010) for the Texas Surface Water Quality Standards, an antidegradation review of the receiving waters was performed. A Tier 1 antidegradation review has preliminarily determined that existing water quality uses will not be impaired by this permit action. Numerical and narrative criteria to protect existing uses will be maintained. A Tier 2 review has preliminarily determined that no significant degradation of water quality is expected in Paddock Lake, Ranger Branch (downstream of Paddock Lake), and Clear Creek which have been identified as having high aquatic life uses. Existing uses will be maintained and protected. The preliminary determination can be reexamined and may be modified if new information is received. The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at City of Sanger Development Services Building, 201 Bolivar Street, Sanger, Texas.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ holds a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. Unless the application is directly referred for a contested case hearing, the response to comments will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period; and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period. TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met.

EXECUTIVE DIRECTOR ACTION. The Executive Director may issue final approval of the application unless a timely contested case hearing request or request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the Executive Director will not issue final approval of the permit and will forward the application and request to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

MAILING LIST. If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. If you wish to be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.

All written public comments and public meeting requests must be submitted to the Office of the Chief Clerk, MC 105, Texas Commission on Environmental Quality, P.O. Box 13087, Austin, TX 78711-3087 or electronically at www.tceq.texas.gov/goto/comment within 30 days from the date of newspaper publication of this notice.




Sanger Museum open on Saturday's

of benefits. Our science labs weren't built to meet current TEA standards, but they do meet middle school standards. Also, our Career & Technical Education programs have grown tremendously, and our amazing instructors who have done great work have extremely limited resources.

The culinary arts program is teaching commercial food preparation classes from a converted bus because the high school doesn't have a classroom with the necessary commercial appliances. Would you believe that Sanger has a robotics program? Like culinary arts, they succeed with less than they need, and the teacher goes above and beyond to give our kids the best education possible. These are just two of many examples of our CTE programs doing the best they can with what they

Why does CTE matter? My son was one of the 47%of Sanger grads to attend a four-year university after graduating. He'll graduate with a bachelor's degree in three years because of Sanger High's dual credit program. More than half of our kids take a different path and enter the workforce after graduation. Many of our CTE students will graduate and move directly into good paying jobs because Sanger ISD prepared them well. This bond will help our district continue preparing our students for success, whether they go to a university or directly in the workplace.

The Ag arena might be my favorite bond project. The Ag Sciences program is the largest student program at Sanger High. As ag parents know, different animals require different environments for daily upkeep and show preparation, and many students don't have space at home for their project animals. The existing facility is inadequate for the current level of participation. A new facility will provide the space needed for our large and thriving Ag program. It will also allow the district to host jackpot shows, which help prepare our students for bigger shows where they can potentially sell their animals for larger scholarship prizes. The existing ag facility will be used as an overflow, which will provide space to accommodate the number of animals our growing program requires. Our Ag Sciences programs win with this bond.

The Athletic Annex is more than just a football building. It will provide more locker space for every outdoor athletic team, boys and girls. Currently, most of our athletes are forced to store their gear on the floor because they don't have a locker. The annex will also provide shelter for student athletes in the case of severe North Texas weather, just steps from where they're competing. As it is, our kids have very little space for this and visiting teams must cross the parking lot and go to the high school for shelter.

One of the thriving CTE programs in SISD is Sports Medicine. Our trainers currently teach classes in a portable building not designed for the type of education being offered. The annex will have classrooms designed specifically for those classes. Then annex also includes the expansion of our concession stands and restrooms. That means more snacks and more restrooms during football games and track meets.

The new instructional spaces in the bond for our Fine and Performing Arts programs will more than double what they currently have. Both programs have outgrown their spaces and. The new high school plan provides additional room and outlines the amount of space allotted, but the instructors of those programs will participate in the actual design of those spaces. After the passage of the bond, they will work directly with the architects to design the layout in a way that best suits their programs. The arts in Sanger win with this bond.

This bond will move all Linda Tutt programs to the current middle school. Ask the leadership at Linda Tutt and they'll tell you this move is a definite win. They'll have more space for their programs, a working kitchen for student meals, and a gym for use during bad weather. If you want to learn more about the beneficial impacts of the programs at Linda Tutt, search online for Sanger ISD in the Houston Chronicle. It will make you very proud to live in Sanger.

Our elementary schools win big with this bond. Clear Creek and Butterfield become 1st-5th grade campuses, Pre-K and Kindergarten move to Chisholm Trail. This will create more space at Butterfield and aligns the district so that no matter which side of 35 you live, your kids will attend the same campus 1st-5th.

I'm going to state this plainly, YES, your property taxes will increase. We all make hard decisions about our families and finances. Even if you don't have kids in our schools, if this won't benefit you directly, we all benefit when our schools improve and excel. I believe that this bond is in the best interests of not only our students and teachers, but every citizen of Sanger ISD. That's why I'm voting YES, and I hope you will too.

WHAT'S IN THE BOND?

GRADE REALIGNMENT

In order to address projected enrollment increases, grade realignment will occur at Butterfield and Chisholm Trail Elementary Schools. This will reduce the number of students and increase the functional capacity at the elementary level within the district.

ADDITIONS AND RENOVATIONS

Clear Creek Intermediate will have a classroom addition and renovations made that will increase the school's functional capacity. This will include a storm shelter, and renovations to the cafeteria and kitchen to match the increased capacity. Capital improvements to the campus including fire protection and controlled entry will also be included in the proposed bond.



FOR 2020/21, SANGER ISD RECEIVED A 98 OUT OF 100 FINANCIAL INTEGRITY RATING WITH THE TEXAS EDUCATION AGENCY.

SAFETY AND SECURITY

The safety and security updates in the bond package include new construction safety standards for the proposed high school, a security vestibule added to Chisholm Trail Elementary, and fire sprinklers installed at Clear Creek Intermediate.

The proposed new high school will provide new science labs, built to the current standards set by the Texas Education Agency. The proposed repurposing of the current high school will ensure that current TEA middle school science lab standards are met.

If approved, the new high school will more than double the space available for both the Health Occupations and Culinary Arts programs. These programs provide students with an opportunity to participate in a work-based learning environment, earn certifications and participate in activities that prepare them for today's labor market.

The proposed new high school will provide additional space for SISD's Fine Arts programs. The instructional and practice space square footage for band and choir will more than double, allowing more students to participate.

AGRICULTURAL SCIENCE CENTER

The current Ag barn was constructed in 1978 and does not have space for large livestock. Bond 2022 includes construction of a new Ag Science facility, with more than 65 pens with turnouts for large animals, exercise area, storage, lockers, and multiple wash and trim stations. It will be designed to allow future jackpot shows to be hosted by our FFA.

ATHLETIC ANNEX

Bond 2022 includes construction of a new athletic annex. All boys and girls outdoor sports will be consolidated in to a single building, including Cross Country, Track, Soccer, Tennis, Softball, Baseball, and Football. A training room for student athlete treatment and instructional space for CTE will also be included.



PREPARING OUR DISTRICT FOR GROWTH

Our district is growing. The Sanger ISD student population is projected to increase by almost 40% within 10 years. That's 1.000+ new students in classrooms and participating in programs across

The 2022 bond proposal is a comprehensive plan developed by 38 members of a Long-Range Facilities Planning Committee, composed of citizens from across the district. These volunteers spent

months learning about school finance, facilities assessments, tax impact data, demographic projections, and more.

The committee process led to the recommendation for a SISD 2022 Bond that includes a new High School and Athletic Annex, a new Ag Science Facility, additions and renovations to existing buildings to increase capacity and improve safety

Meet Bob and Meredith Matthews, owners of All American Dogs (AAD) a city shelter. It is run by All American Dogs, a private animal control company. AAD provides animal control and code enforcement to over 29 municipalities in the DFW area. They have partnered with Sanger for the last 9 years.



With April being Pet Appreciation month, I contacted Kirk Sissner, Shelter Manager, and asked if he could arrange a behind-the-scenes tour and have someone tell me more about the shelter. Owners Bob and Meredith, along with Kirk and AJ (both Shelter Managers), were more than happy to show off the facility. It was straightforward to understand why instantly. We have all been to pet shelters. I have often walked away feeling very sorry for the animals and their living conditions. This was not the case at All American Dogs.

Let me first say that this facility was excellent. The staff has a genuine love for all animals. And the animals that come to AAD are living their best life. I was thrilled to see that currently, they don't have

a lot of cats. I am a cat person, terrified that I would get there, feel sorry for all Animal Shelter in Pilot Point. AAD is not the cats, and try to bring them all home. These little guys and gals are living their best life. The animals don't spend all their time behind bars. Every animal (all 89 - cats and dogs combined - as of the day of my visit) gets human playtime every day. If you are in the market for a cat, might I suggest Twinkie? He is

> about five years old and a complete lover. He is a high attention cat that wags his tail and sits. Adorable!

AAD has been in business for just over 14 years. This amazing facility

sits on 12+ acres. Owners Bob and Meredith have been steadily building and improving the shelter. Currently, they are in the process of adding an additional cat room and adding a brand-new building for their dogs. Additionally, as the new facilities come online, the older buildings are being remodeled to provide the animals with the best housing facilities available. AAD is considered a no-kill shelter. Animals don't get put down just because they have been there a long

time. They boast a 90+% adoption rate. They are careful as they grow their facility not to grow so big that it negatively affects the animals under their care. They partner with Petco to show and get their animals into forever homes. Additionally, they partner

with Adopt a Pet and Miles of Hope Animal Rescue to list all of their animals online.

If you visit All American Dogs, you will notice they have some unexpected pets on the property. Their primary focus is on domesticated animals (dogs and cats). However, they do have three pot-belly pigs that are crazy cute. These pigs act a lot like

dogs. They love pats on the head, and if you rub their bellies, you are certain to have a friend for life. They share a very large field with a donkey and several goats.

Upon entering the facility's main office, you will notice a couple of very large fish tanks. They don't necessarily

take fish but having the tank did originate from a surrender. Now they breed Cichlids and sell them. Next to the front desk, Kada, a beloved bearded dragon, is nestled in her habitat. Don't go there to adopt her. The Matthew's and staff have decided she now belongs to the shelter. She is exceptionally cared for and spends many hours outside her cage being loved by everyone.



AAD offers many services. First and foremost, you can find your new family member at the facility. They encourage



visitors to call before coming to the property. They have a pet surrender program, and concerned residents can file a code enforcement complaint or report an animal control concern. Additionally, when your 4-legged family member crosses over the rainbow, they provide cremation services along with a memorial cast of your furbaby's paw print.



While the animals at All American Dogs are living great lives, they all would love to go to forever homes. Right now, they have 70+ dogs that need homes. I was fortunate to get to spend time with all of them. One, in particular, Wilson, a six-year-old American Bulldog Mix, stole my heart. This little guy is super friendly and affectionate. He is not an easily excitable dog. While all the dogs around me were barking and vying for my attention, he came up close and sat by me while waiting for me to notice him. AJ, Shelter

Manager, informed me that he is always very chill. He explores his area then likes to come to be by your side. According to his profile, he is excellent with other dogs, great with kids, and house-trained.

When you adopt a pet from AAD, it will be 100% up-to-date with its shots; it will be spayed or neutered, microchipped, and tested and treated if positive for heartworms. While the shelter doesn't do an FBI check on you before you can adopt a dog, they do want to meet you and talk to you. Their goal is to make every effort to place the animal in a forever home. They want to make sure that the adopters of the animals are ready for a furbaby and that the baby they are getting fits nicely into their lifestyle.

We have always solicited numerous grocers to come to town and have done economic studies to show them the gap need. Many prospective grocers, in the past, have said that the community household demand numbers were just on the verge of their desired economic trade base. With the FM 455 expansion and the loss of the current grocery store, our available trade base just got larger; there is a larger gap now between demand and supply within our trade area. Consequently, there has been much more interest from grocer developers willing to look seriously at Sanger.

10. What would you say to residents about the current state of the streets that are in need of repair? And if you believe more money should be made available for ongoing street repair, where will this money come from? If you have carefully watched the city over the past 10 years, you have seen some significant changes in the city street infrastructure. We began with some of the significant collector streets (i.e., Keaton, 2nd, Freese, etc.). On many of these, we replaced the underlying infrastructure as we rehabbed them.

Along the way, we rehabbed various areas within the city (i.e., the Indian Springs neighborhood, Wayne and Jackilu neighborhood, Holt and Berry around the school, Smith, Sims, Kirkland, Melinda Myrl, etc.).

With many of the collector streets and neighborhood streets improved, the Council entered in to a 5-year plan several years ago to improve the streets in the center of town. You have seen the acceleration of several years of these steps over the past few years with many internal streets being resurfaced. We are not yet finished with this plan and recognize that we still have work to do, but I and your Council remain committed to this process.

We also stretched Sanger citizens' tax dollars by partnering with the County to totally redesign and rebuild McReynolds Road ahead of the FM 455 work, in order to provide a better secondary way into and out of town as we anticipated the traffic challenge of the FM 455 work. Likewise, we are currently advocating with the County for use of some of its future bond funds for the rehab of Marion Rd., Belz Rd. and Duck Creek Rd. If we can leverage County funds for these larger projects at the edge of our city boundaries, we can further stretch city taxpayer dollars.

Sanger's growth will likely continue to allow us to keep a stable or declining property tax rate, while still accomplishing significant ongoing street rehab programs.

11. What do you believe are the most important projects to be either started or completed in the city in the next two years? The big projects that will impact the city most visually and impact immediate growth will be the completion of FM 455 and the coming I-35 expansion. While these are both initiated by TXDOT, we have to manage the city's portion of the project and understand the longer-term positive impact of what is likely to be a challenging time of construction.

Beyond these obvious projects, you can be certain that we are watching closely all the services and infrastructure necessary to maintain services for all residents as the town grows. I call these areas the "blocking and tackling" of city work. It includes our police, fire, EMS, electric, water, wastewater, etc. It is these folks in our city staff that make it all work.

One example of how we made appropriate investment and contractual decisions was during the freeze of February 2021. I could not have been prouder of our city employees and leadership during the freeze that incapacitated many other cities. We had proactively contracted on a fixed-rate contract for our electricity. Our electric department made sure we did not exceed our contracted amount with minimal, well-timed and consistent periods of down time. Consequently, the rate payers of Sanger received no additional ancillary charges and did not have to pick up any of the state deficit caused by the historic outage. Likewise, our water department kept wells running and unfrozen; we avoided a boil notice in Sanger, while other communities around us suffered with this inconvenience.

12. Is it important to you to keep the property tax rate from rising for the residents of Sanger? The only time the city has raised property taxes in my twelve-year tenure was in 2013 and it was solely for the purpose of putting additional funds toward streets. Otherwise, Council has maintained a steady tax rate and even lowered the property tax rate in the most recent budgetary cycle. Sanger's growth will likely continue to allow us to keep a stable or declining city property tax rate, while meeting our growth needs. Just like with your personal budget, we want to make prudent expenditures and live within our means for our normal ongoing expenditures. We only want to use longer-term debt to fund infrastructure with long useful lives. The city's property tax rate is only about 30 percent of the overall property tax paid by residents and we are very aware of the need to only generate revenues that allow us to meet the needs of the community -- no more.

13. Do you think our main street/downtown is healthy and successful? I believe the downtown is healthy and continues to improve. We have the "bones" of a strong historical downtown that many communities wished they had or try to build. The new Sanger 2040 Comprehensive Plan identified some elements that may be helpful to further develop the downtown area and we will be exploring these items going forward.

However, we cannot escape discussing the challenges of the COVID era that was a very trying time for small businesses everywhere, including Sanger. We had many creative businesses that found a way to adjust and survive through this difficult time. In a small town, we are always grieved when we see a local small business suffer at no fault of their own; this was difficult. The city partnered proactively with the county to use some of its stimulus funds for our local businesses.

Our town was resilient, and our overall sales tax revenue maintained and continued to grow during this period. This is a testament to current businesses and new ones that came into the downtown area and other areas of the city. This occurred even in the period where other sales tax revenue generators were also affected negatively by the FM 455 expansion. I am grateful for all the hard work our Sanger area businesses have done over the past few years – it shows.

14. What's most important for the city as far as growth and new homes being built? We want quality growth, not just growth for the sake of growth. Yet, we need growth to draw the local conveniences and services that our citizens desire. It is important to build a larger commercial and retail base that would allow citizens to get their goods and services locally. Additional households are required to attract further retail development. This also has the likely benefit of reducing the residential property tax burden over time. For some years now, Council has laid out a desired mix of housing that is aimed to improve the size and quality of Sanger's housing mix, all to improve the overall future lifestyle for residents.

15. If you could change one thing in our zoning code, what would it be and why? The zoning code is meant to allow for consistent development of both residential and business-type enterprises in a cohesive and planned manner. We are looking at the new Sanger 2040 Comprehensive Plan and seeing what changes might be necessary to achieve the vision that citizens shared with the city. This will likely include some changes along the FM 455 area and some of the allowed business and housing types around downtown to allow for a walkable area within historic downtown. By using the rehab of FM 455 and I-35 as a catalyst to consider any zoning redesignations, we hope to further facilitate a quality look and feel for Sanger.

16. If you received a \$1 million grant to use for the city any way you wanted, what would you do with it and why? We are currently looking for ways to incent the acceleration of improved city-wide internet infrastructure with a move toward gig-a-bit status. One option for additional grant funds would likely be this type of infrastructure improvement that is brought to the city by outside internet providers. With improved internet speeds, we can draw workers that work locally or remotely, while being within a short trip into the metroplex for periodic business and customer meetings. Greater internet speed and access would also improve the availability of education for Sanger's students and families. Both of these needs became apparent during the past few years. Sanger is an ideal place to raise your family locally, while accessing broader work and business opportunities metroplex wide.

17. Where are your favorite places to spend time in town? My family likes going for walks in the Sports Park. Our dogs love the outing and we enjoy the fresh air and seeing others from around town.
