## City officials meet with TxDOT engineers before Public Meeting on Thursday

City of Sanger officials met with the TxDOT project engineers, recently. The FM 455 project is a little ahead of schedule. According to Ramie Hammonds, Economic Development Director for the City of Sanger. TxDOT is about 90% complete with acquiring properties. The plan for the relocation of the utilities along FM 455 will be about 60% complete by June 2019. The Right Of Way (ROW) should be clear of structures by February 2020, and all utilities relocated by October 2021. The project should be clear to start February 2022. Per engineers these dates could move forward if the project stays ahead of schedule.

Regarding the properties at the intersection of I-35 and FM 455, the plan is to construct the bridge in conjunction with the FM 455 project, which would be ahead of the I-35 project. The ROW acquisition for that area has not been completed. They are expected to start those acquisitions in the next few months.

The Texas Department of Transportation (TxDOT) is proposing to widen and reconstruct IH 35 from US 380 (University

Drive West) to approximately 0.7 mile north of FM 3002 (Lone Oak Road) in Denton and Cooke counties, Texas. A draft environmental assessment (EA) is available for public review and that TxDOT will be conducting a public hearing on the proposed project. The hearing will be held on Thursday, April 4, 2019 at the Sanger High School Cafeteria, located at 100 Indian Lane, Sanger, TX 76266. Displays will be available for viewing at 6 p.m. with the formal hearing starting at 7 p.m. The purpose of the public hearing is to present the proposed project to the public and receive comments.

The proposed improvements would begin north of the IH 35 east/west split in the City of Denton and extend north along IH 35 through the City of Sanger to just north of FM 3002 in Cooke County, for a total distance of approximately 15.1 miles.

## GreenFest to be held April 6 at Ray Roberts

GreenFest on the Greenbelt 5K is an event centered around health, wellness, and recreation. It will have food and activities for the whole family including bounce houses, food trucks and live music. This is not your every day 5K, this one is unique because of the surroundings and the unique experience in the festival area. The 5K will be timed and almost entirely off-road, the course will take you along the beautiful Greenbelt Trail and across the historic Elm Fork Bridge. The 1 Mile Fun Run will be around the festival area for all of the spectators to enjoy. Runners and walkers of all ages and abilities are welcome. Dogs on a leash are welcome to join, strollers



are welcome but the course will be very challenging for a stroller.

GreenFest on the Greenbelt is presented by The Greenbelt Alliance of Denton County, A 501(c)3 nonprofit. They are a community-based, volunteer organization that fosters awareness of the Greenbelt. The goal of this event is to raise funds for the Texas State Parks and Wildlife Department. Last year they raised over \$4000.00 and hope to at least double that this year. The funds donated are kept local and used to improve the Greenbelt as well as Ray Roberts Lake State Park

All participants of the 5K will receive a swag-bag with sponsor goodies, event t-shirt, finisher medal and finish line refreshments.

The 5K will have prizes for the top 3 overall male and female finishers as

## Congressional Medal of Honor Recipient Motorcade coming through Sanger on Wednesday, April 10

The annual trek of Congressional Medal of Honor Recipients flying into DFW Airport and traveling to Medal of Honor Week-end put on by the Medal of Honor Host City Program of Gainesville will be occurring Wednesday, April 10, 2019.

As usual, there will be a large motorcade of public safety vehicles honoring and escorting these National Heroes all the way to their destination in Gainesville. This year will be exceptional with a historic number of public safety agencies participating in the motorcade.

Current estimates are expecting the motorcade to stretch 8-9 miles long with well over 550 vehicles participating. At this time we are expecting the motorcade to leave the staging area on the South end of DFW Airport tentatively between 4:00pm - 5:00pm.

With such a significant number of participants, citizens traveling along this

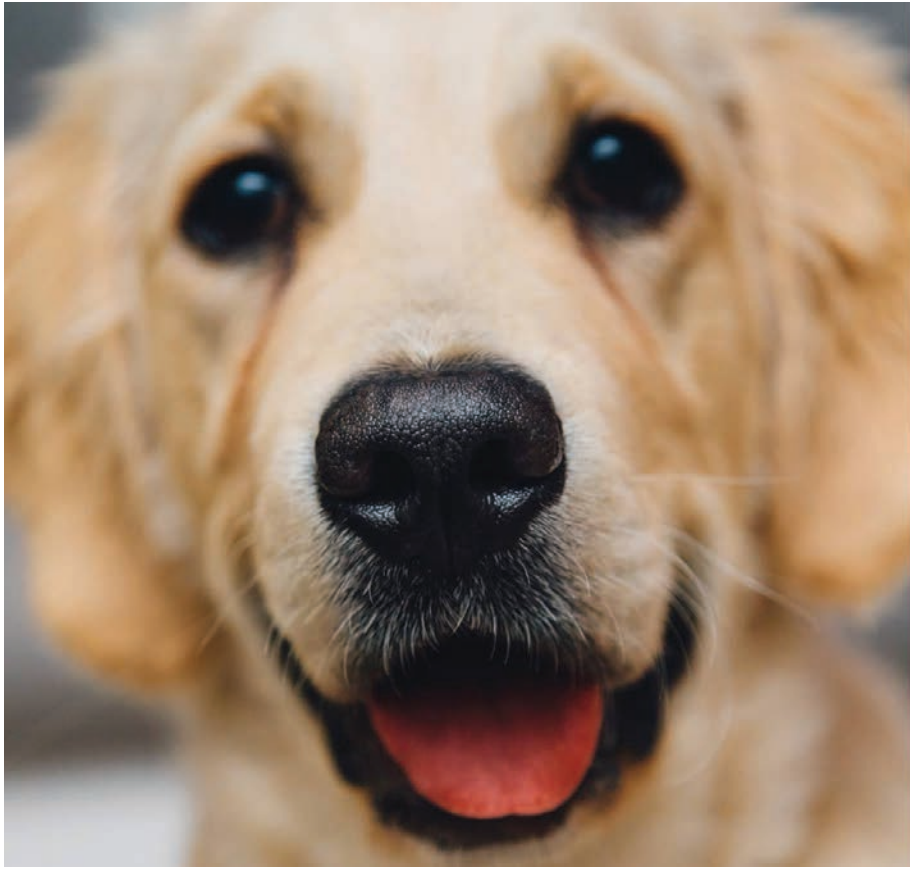
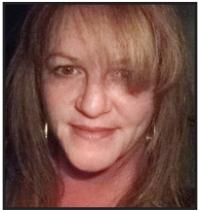

Emily Walker, daughter of Nancy and Dale Walker, and a Senior at Sanger High School, has been selected as a member of the American Kennel Club 2019 European Open Junior (EOJ) Agility Team USA by Coach Susan Cochran. The AKC Junior EOJ Team USA is made up of 19 dog and handler teams from across the U.S. Emily and her Miniature Poodle Lyra will represent Team USA as one of four Small Dog Teams which are made up of three Shetland Sheepdogs and a Miniature Poodle. She is very excited and honored to represent the USA and North Texas in the sport that she loves.

Currently there is no such thing as a dog agility competition at the Olympics. But to the junior handlers and their K-9 partners selected to represent the USA in Switzerland, this is just as thrilling! Traveling the world to compete at the highest level of dog agility takes training, athleticism, commitment and dedication.

The EOJ is an agility competition which is officially recognized by the Federation Cynologique Internationale as the largest international federation of kennel clubs. The competition is open to all dogs (minimum 24 months),

children (born 2004 and younger) and juniors (born 2000-2003). The individual dog competition categories are held in Large (shoulder height over 16 7/8") Medium (shoulder height 16 7/8" or less) and Small (shoulder height 13 3/4" or less).

May, who has earned certifications as a Government Finance Officer and County Investment Officer, is president of the Texas Association of County Auditors.

## County commemorates opening of Section 5 of FM 2499 with ribbon cutting

We hosted a ribbon cutting ceremony to commemorate the completion of FM 2499, Section 5, on March 22 with fellow members of the court, mayors from area cities and representatives of state and federal officials. Today, FM 2499 serves as a significant regional arterial from the DFW Airport to I-35E, providing a needed alternative and congestion relief to I-35 E as well as the FM 2181 corridor where significant growth is happening in this part of the county. The project represents a partnership between the county, TxDOT, the North Central Council of Governments, federal agencies and surrounding municipalities.

The FM 2499 Task Force began working on this project in 1984 under the leadership of former Highland Village Mayor Kay Stephens. By 1991, Denton County assumed financial and leadership responsibilities with the passage of the county’s first road bond program. FM 2499 would be included in two future bond programs in 1998 and 2004. TxDOT Area Engineer Tina Massey told the crowd that the project construction cost was about \$40 million. Webber, LLC completed construction in November 2018. Other officials marking the completion of FM 2499, Section 5, included City of Denton Mayor Chris Watts and City of Corinth Mayor Bill Heideman. Representatives of Congressman Michael Burgess, Senator Jane Nelson and Rep. Lynn Stucky also attended.

## Regional road and bridge updates

FM 720 North - In April, crews will place asphalt, tie steel, and place concrete pavement for northbound FM 720 lanes. Place inlet tops at northbound FM 720 lanes. Mayhill Road – Several utility poles remain on the south end of the project and will be removed following the recent traffic switch. The second phase of construction is underway. I-35E/Loop 288/Brinker/Mayhill – Main line asphalt paving; construction of retaining walls and entrance ramp. U.S. 377/Stewart/Arvin Hill Intersection Improvements – TxDOT is reviewing 60 percent plans for the intersection improvements. The county is revisiting signalization with TxDOT. TxDOT has approved an access permit for the realignment of Arvin Hill. Union Hill/ FM 455/ FM 2164 Realignment Project – In March, crews worked to install signs with superpaving done at FM 455/Union Hill and FM 455/FM 2164 south. For April, the focus will be on vegetation. U.S. 380 East – (Loop 288 to U.S. 377) The TxDOT design team is working on 95 percent plans with an estimated timeline for submittal of May 2019. (U.S. 377 to county line) The consultant continues to work on the 95 percent plans. The estimated timeline for submittal is July 2019. U.S. 380 Feasibility Study – Following public meetings in January, a second public meeting is anticipated in the summer.

The U.S. Navy veteran was awarded the Medal of Honor from President Donald J. Trump during a White House ceremony May 24, 2018, for his actions during combat operations on March 4, 2002, while deployed to Afghanistan in support of Operation Enduring Freedom, according to his biography on the U.S. Navy’s website. Three widows of MOH recipients will also be attending, Moore said. They are Ruby Lucas, Patricia Pittman and Sally Jackson.

The city of Gainesville is the only Medal of Honor Host City in the United States, according to Moore. # USA Equestrian Spencer Roberson Sweeps Gold at his First World Games

Spencer Roberson of Sanger is the son of Randy and Roxanne Roberson. He is an accomplished athlete and volunteer who made his international debut at the Special Olympics World Games Abu Dhabi 2019. The Special Olympics USA athlete swept gold every category of equestrian including dressage, English working trails, and English equitation. People might recognize Spencer from D&L Farm and Home in Sanger. He's worked there the past few years.

Although this is Spencer's first Special Olympics World Games, he has spent more than ten years competing on the elite equestrian circuit in his home state of Texas and across the United States. He has won two AQHA Congress Championships, multiple AQHA (American Quarter Horse Association), NSBA (National Snaffle Bit Association) and PHBA (Paint Horse Breeders Association) High Point and Reserve High Point Awards.

Spencer's decorated career began at Stable Strides Farm, an organization that provides a positive place for people with disabilities—as well as retired and active duty veterans – to become more confident, independent, and competitive equestrians. When he is not in the arena, he volunteers 20 to 30 hours a week with Stable Strides Farm and supports riders of all abilities as they develop their equestrian skills.

“Spencer has probably done the most volunteering with the veterans program,” says Mandy Cleveland, Program Director at Stable Strides Farm. “He also volunteers at the barn helping our other riders get their horses ready...I teach about 25 riders and many times he is my only volunteer.”

Influenced by their experience and friendship with Spencer, some veterans were motivated to volunteer with Stable Strides Farm's program for equestrians with intellectual disabilities.

“[The veterans] have begun volunteering in the program, and they have said that it makes them more aware of our [riders'] abilities instead of their disabilities,” Mandy continues. “They know how hard riding is, and after seeing our riders be successful, they have realized the talent that people with intellectual disabilities have.”

ESPN is doing what they call 50 game changers. Spencer Roberson and Stable Strides Farm, INC is going to be one of the game changers. They will be coming to the barn soon to finish taping. It will be aired at a later date.

After a stunning performance at World Games, Spencer is excited to celebrate with his family and friends back home – but eager to top his gold medal performance at Special Olympics World Games Berlin 2023.



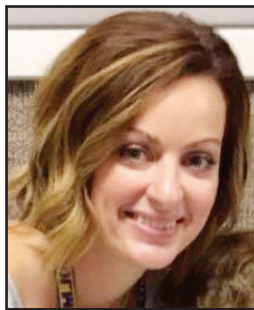

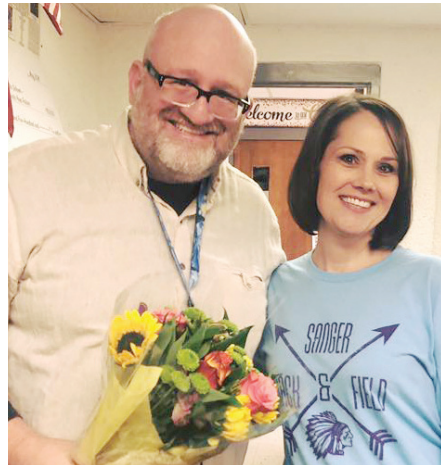
