**All public boat ramps, Johnson Branch beach open while Isle du Boise day use area closed for major repair project**

Buck Creek boat ramp in Tioga opened last week, and now all of the public boat ramps are open after most of them closed a month ago when Lake Ray Roberts was nearly five feet high. Ray Roberts is just under six inches high, but TP&W Isle du Boise State Park day use has been closed since May 29 for a major capital repair project until fall 2019. The closure includes the swimming area, picnic area and pavilions.

"We are excited the renovations to the flood damaged areas at the park are underway and we look forward to having the new and improved facil-

ities once the projects are completed," a representative put on the parks facebook page. "Although these repairs will impact plans for this summer, the improvements will enhance the park experience for our visitors in the future."

During the closure, the campgrounds, trails and boat ramp will remain open for use, pending weather and flooding conditions.

All facilities at Johnson Branch State Park are open, including the beach area. Both parks have announced several events for July. See more on page 4:
